## ORDINANCE NUMBER 78

AN ORDINANCE REJECTING ALL PRIOR BIDS PERTAINING TO SEWER SYSTEM IMPROVEMENTS AND REAUTHORIZING THE ACCEPTANCE OF NEW BIDS FOR SEWER SYSTEM IMPROVEMENTS IN THE CITY OF ARCADIA, MISSOURI.

WHEREAS, the City of Arcadia, by and through its Board of Aldermen, has determined that the previous bids accepted for sewer system improvements shall be rejected and rebid in the hopes that more construction companies will participate in the bidding process and the City of Arcadia, as a result, will be able to have this work performed at a lower price, thereby reducing the tax burden on its citizens, and

WHEREAS, the City of Arcadia, by and through its Board of Aldermen, has been informed by the Missouri Department of Natural Resources and the United States Environmental Protection Agency that the rejection of these prior bids has been approved and authorized by these governmental agencies and has further authorized the re-advertising and rebidding of work pertaining to the sewer system improvements of the City of Arcadia, Missouri,

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ARCADIA, MISSOURI, AS FOLLOWS:

Section 1. Inconsistent ordinances repealed. All other ordinances or parts of ordinances in conflict herewith

are hereby repealed and made ineffective upon adoption of this ordinance. Any ordinances presently in existence in the City of Arcadia dealing with the subject matter of this ordinance shall be read so as to comply and be consistent with this ordinance. If there are any conflicts, then the provisions of the codes adopted herein shall prevail.

Section 2. Rejection of Bids. All bids heretofore received on Project No. 7039.014 and known as, respectively, Contract I and Contract II are hereby rejected due to irregularities in several of the bids received, thereby not allowing the City to accomplish the project at the lowest cost to the taxpayers of the City of Arcadia.

Section 3. Re-advertisement and rebidding. The City of Arcadia authorizes the engineering firm of Stack and Associates, Inc. to re-advertise for bids for a period consistent with the bid documents previously authorized by the City of Arcadia.

Section 4. Work to be Done by Bidder. Further, Stack and Associates, Inc. is hereby directed to require in the bidding documents that any general contractor bidding on either or both projects shall affirm and be required to perform a minimum of seventy percent (70%) of the construction work. The City has determined that the health, safety and welfare of its citizens is best served by

requiring bidders to likewise be the actual companies that will do the construction work.

Section 5. This ordinance shall be in full force and effect from and after its passage and approval.

WHEREUPON, this ordinance was read three times and approved by vote of the Board of Aldermen of the City of Arcadia, Missouri, on this \_\_\_\_\_ day of March, 1990.
