**ORDINANCE NO: 46-1A** 

## AN ORDINANCE ESTABLISHING RATES FOR WATER SERVICES

WHEREAS, the City of Arcadia establishes rates for water services; and

WHEREAS, the Board of Aldermen has determined that the increased cost of providing water services for Arcadia citizens and businesses necessitates an increase in the rates currently established in order for the waterworks to maintain a sound financial condition and meet obligations.

## NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ARCADIA, MISSOURI, AS FOLLOWS:

SECTION 1. BI-MONTHLY RATES ESTABLISHED. The following rates and charges for the use and services of the combined waterworks and sewer system of the City of Arcadia, based on the amount of water consumed, are hereby established:

This rate shall be voted on annually, in December, to be increased by 3% annually, beginning January 2022.

## Water Rates

Property <i>Inside</i> City Limits	
0-4,000 gallons	\$16.91
Per 1,000 gallons for the next 12,000	\$ 3.08
Per 1,000 gallons after 16,000	\$ 2.20
Property Outside City Limits	
0-4,000 gallons	\$25.64
Per 1,000 gallons for the next 12,000	\$ 4.64
Per 1,000 gallons after 16,000	\$ 3.21

Whenever, for any cause, a water meter fails to operate, a reasonable estimate shall be made of the amount supplies during the period such meter fails to operate, and the user shall pay a rate based in whole or in part on the estimated amount of water supplied.

SECTION 2. SEVERABLILITY. The sections, paragraphs, sentences, and clauses of this Ordinance are severable, and if any section, paragraph, sentence, or clause of this Ordinance is declared to be unconstitutional by a court of competent jurisdiction, such unconstitutionality shall have no effect upon the remaining sections, paragraphs, sentences, and clauses of this Ordinance.

SECTION 3. REPEAL CONFLICTING ORDINANCES. All Ordinances or parts of Ordinances in conflict herewith shall be, and the same are hereby repealed; and this Ordinance shall be in full force and take effect from and after its passage and approval as provided by law.

SECTION 4. EFECTIVE DATE. This Ordinance shall take effect immediately upon its final passage by the Board of Aldermen of the City of Arcadia, Missouri. The revised rates shall be applied beginning January 2022; in particular, rates shall be applied to bills mailed on or about March 1, 2022.
