ORDINANCE NUMBER 1

AN ORDINANCE REVISING AND CONSOLIDATING THE ORDINANCES OF
THE CITY OF ARCADIA, IRON COUNTY, STATE OF MISSOURI.

WHEREAS, it is expedient that the Ordinances of
the City of Arcadia should be revised, consolidated and
arranged in appropriate chapters, articles and sections, and
that the whole should be made concise, clear and
intelligible; Now, Therefore,

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF
ARCADIA, MISSOURI, as follows:

SECTION 1. That the following shall constitute and be
denominated, known, taken and accepted as the revised
ordinances of the City of Arcadia, and shall be recorded in
the Book of Ordinances by the City Clerk of said City, and
published according to law, properly arranged with table of
contents, paged and indexed, and when published with the
certificate of the City Clerk, under the seal of said City,
shall take effect and be in force as therein specified, and
shall be received in all courts and places of judicial
investigation without further proof.

SECTION 2. Any of said ordinances or any part of either of
them, relating to the omission or commission of any act or

offense, whether the words "within the corporate limits of the City of Arcadia" or words of like import are used in connection therewith or not, shall be deemed taken, interpreted and understood as including said words.


Whenever in any of said Ordinances the word "City" occurs, unless otherwise specified, it shall be deemed to mean the City of Arcadia. Every ordinance and part thereof shall be deemed to apply to persons and things in the singular and plural numbers and to male and female alike, when applicable, unless otherwise specified.

SECTION 3. All ordinances of a general or public and permanent nature heretofore passed, not contained in the following ordinances, nor expressly repealed thereby and conflicting with the ordinances herewith published, be and the same are hereby repealed; but no fine, forfeiture, penalty, right, action, suit, debt or other liability whatever, created, incurred or accrued by or under the same, shall be released or otherwise affected, but may be prosecuted or recovered in the same manner and as fully as if such ordinance or part thereof had remained in full force.

SECTION 4. All ordinances of a private, local or temporary nature, now in force and not included in the following Revised Ordinances of the City of Arcadia, shall continue in

force and expire according to their respective provisions or limitations.

WHEREUPON, this ordinance was read three times and approved by vote of the Board of Aldermen of the City of Arcadia, Missouri on this 16TH day of DECEMBER, 1987.
