

ORDINANCE NO. 34

AN ORDINANCE RELATING TO THE REPRESENTATION OF THE CITY OF  
ARCADIA ON THE ARCADIA VALLEY COMMUNITY PARK BOARD.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ARCADIA,  
MISSOURI, AS FOLLOWS:

SECTION 1. As there is no Arcadia City Ordinance pertaining to the appointment of the four (4) City of Arcadia representatives allotted to represent Arcadia on the "Arcadia Valley Community Park Board" all appointments having been made by the Mayor and approved by vote of the Board of Aldermen.

SECTION 2. All appointments heretofore made and approved are by this Ordinance rescinded.

SECTION 3. The Mayor shall make initial appointments to the "Arcadia Valley Community Park Board" to represent the City of Arcadia shall be made by the Mayor and approved by the Board of Aldermen as follows:

On or before the Regular Meeting of the Board of Aldermen for the Month of May, 1996 the Mayor shall appoint and the Board of Aldermen shall approve four (4) "Qualified residents" of the City of Arcadia to serve on the "Arcadia Valley Community Park Board" for period of time as follows:

Two (2) for a Three Year Period  
Two (2) for a Two Year Period

Appointments following the original period shall be for Two (2) year periods. A "Qualified Resident" under this Ordinance is a person who is a registered voter of the City of Arcadia who has

been a resident of the City of Arcadia at least one (1) year prior to appointment.

**SECTION 4.** When vacancies occur in the representation of the City of Arcadia on the "Arcadia Valley Community Park Board" the Mayor shall appoint a "Qualified Resident" with the approval of the Board of Aldermen to serve the remainder of time on the Board left by the person who vacated the position.

**SECTION 5. REPEALING CONFLICTING ORDINANCES.** That all Ordinances of parts of Ordinances in conflict herewith, shall be in full force and in effect from and after its passage and approval as provided by law.

**SECTION 6. SEVERANCE CLAUSE.** That if any section, sentence, phrase or clause of this Ordinance shall be held to be invalid for any reason be a court of competent jurisdiction, the invalidity of such section, sentence, phrase or clause shall not impair the validity of the remaining section, sentence, phrase or clauses of this Ordinance: the Board of Aldermen hereby declares that it would have passed the remaining portions of this Ordinance had it known that such section, sentence, phrase or clause would be held invalid.

**WHEREUPON,** this Ordinance was read three times and approved by vote of the Board of Aldermen of the City of Arcadia, Missouri, on this 11th day of March, 1996.
