

ORDINANCE NUMBER 10-A

AN ORDINANCE RELATING TO SALARIES OF CITY OFFICIALS AND WAGES OF CITY EMPLOYEES.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ARCADIA, MISSOURI, as follows:

SECTION 1. SALARIES OF CITY OFFICIALS. The salaries for city officials shall be as follows:

- A. Mayor shall receive \$225.00 per month.
- B. Members of the Board of Aldermen shall receive \$35.00 per month.
- C. The salary of any elected officer of the City of Arcadia shall not changed during the time for which he/she was elected. The changed salary will affect only the elected officials coming into office that year.


SECTION 2. WAGES OF EMPLOYEES. The wages of all employees of the City of Arcadia shall be negotiated and decided upon by agreement between the Mayor of the City of Arcadia and the Board of Aldermen.

SECTION 3. SEVERANCE CLAUSE. That if any section, sentence, phrase or clause of this ordinance shall be held to be invalid for any reason by a court of competent jurisdiction, the invalidity of such section, sentence, phrase or clause shall not impair the validity of the remaining sections, sentences, phrases or clauses of this ordinance: the Board of Aldermen hereby declares that it would have passed the remaining portions of this ordinance had it known that such

section, sentence, phrase or clause would be held valid.

SECTION 4. REPEALING CONFLICTING ORDINANCES. That all ordinances or parts of ordinances in conflict herewith, shall be and the same are hereby repealed; and this ordinance shall be in full force and effect from and after its passage and approval as provided by law.

WHEREUPON, this ordinance was read three times and approved by vote of the Board of Aldermen of the City of Arcadia, Missouri on this 31st day of March, 1997.

ORDINANCE NUMBER 10-B

AN ORDINANCE RELATING TO SALARIES OF CITY OFFICIALS AND WAGES OF CITY EMPLOYEES.

SECTION 1. SALARIES OF CITY OFFICIALS. The salaries for city officials shall be as follows:

A. Mayor shall receive \$400.00 per month.

B. Members of the Board of Aldermen shall receive \$35.00 per month.

C. The salary of any elected officer of the City of Arcadia shall not be changed during the time for which he/she was elected. The changed salary will affect only the elected officials coming into office year.

SECTION 2: WAGES OF EMPLOYEES. The wages of all employees of the City of Arcadia shall be negotiated and decided upon by agreement between the Mayor of the City of Arcadia and the Board of Aldermen.

SECTION 3. SEVERANCE CLAUSE.
