ORDINANCE NO. 68

AN ORDINANCE AUTHORIZING THE ADOPTION OF THE MISSOURI MODEL TRAFFIC ORDINANCE.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ARCADIA, MISSOURI, AS FOLLOWS:

WHEREAS, the Section 300.600 RSMo authorizes the Board of Aldermen for the City of Arcadia to adopt by reference all or any designated part of Chapter 300l, Model Traffic Ordinance; and

WHEREAS, the Board of Aldermen for the City of Arcadia have determined that it is in the best interest of the City to adopt all of Chapter 300, as the Traffic Ordinances for the City of Arcadia;

NOW, THEREFORE, BE IT ORDAINED by the Board of Aldermen for the City of Arcadia, Missouri, as follows:

<u>Section 1. Adoption of RSMo. Chapter 300</u>: The Board of Aldermen for the City of Arcadia hereby adopts Chapter 300 and each subchapter thereunder to be the traffic ordinances of the City of Arcadia, Missouri, said ordinances to be enforced by Municipal Court of the City of Arcadia.

Section 2. Penalty for Violation: Any person who shall violate any of the terms and regulations of Chapter 300 or any sub-chapter thereof as enacted by this Ordinance, may, upon conviction, be fined not less than ten dollars (\$10.00) nor more than Five Hundred dollars (\$500.00) and/or be sentenced to served not less than one day nor more the ninety (90) days in the Iron County Jail.

Section 2. Severability. The Sections, paragraphs, sentences and clauses of this ordinance are severable; and if any section, paragraphs, sentence or clause of this ordinance is declared to be unconstitutional by the Court of competent jurisdiction, such unconstitutionality shall have no effect upon the remaining sections, paragraphs, sentences and clauses of this ordinance.

<u>Section 3. Repeal Conflicting Ordinances</u>. All ordinances or part of ordinances in conflict herewith shall be, and the same are hereby repealed; and this ordinance shall be in full force and effect from and after its passage and approval as provided by law.

Section 4. Effective Date. This ordinance shall take effect immediately upon its final passage by the Board of Aldermen of the City of Arcadia, Missouri.
