## ORDINANCE NUMBER 69

# AN ORDINANCE REGULATING THE SPEED OF MOTOR VEHICLES WITHIN THE CITY OF ARCADIA, MISSOURI

# BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ARCADIA, MISSOURI, as follows:

#### Section 1. State Speed Law Applicable, Where.

The state traffic laws regulating the speed of vehicles shall be applicable upon State Highway 21 within the boundaries of the City of Arcadia, Missouri.

### Section 2. Speed Limits Established.

It shall be unlawful to drive at a speed in excess of thirty miles per hour on all streets, avenues and highways within the city limits, unless otherwise posted.

### Section 3. Speeding in a Construction Zone.

Pursuant to Section 304.580, RSMo., there shall be an additional fine of two hundred fifty dollars (\$250.00) for speeding or passing in a construction zone if a construction worker is present. A sign shall be erected by the Missouri Department of Transportation warning drivers that a two hundred fifty dollar (\$250.00) fine will be imposed for speeding or passing in a construction zone.

#### Section 4. Penalty for Violation.

Except as otherwise provided herein, any person who shall violate any of the terms and regulations of Chapter 300 or any sub-chapter thereof as enacted by this Ordinance, may, upon conviction, be fined not less than ten dollars (\$10.00) nor more than Five Hundred dollars (\$500.00) and/or be sentenced to served not less than one day nor more the ninety (90) days in the Iron County Jail.

<u>Section 5. Severability.</u> The Sections, paragraphs, sentences and clauses of this ordinance are severable; and if any section, paragraphs, sentence or clause of this ordinance is declared to be unconstitutional by the Court of competent jurisdiction, such unconstitutionality shall have no effect upon the remaining sections, paragraphs, sentences and clauses of this ordinance.

<u>Section 6. Repeal Conflicting Ordinances</u>. All ordinances or part of ordinances in conflict herewith shall be, and the same are hereby repealed; and this ordinance shall be in full force and effect from and after its passage and approval as provided by law.

<u>Section 7. Effective Date</u>. This ordinance shall take effect immediately upon its final passage by the Board of Aldermen of the City of Arcadia, Missouri.
