AN ORDINANCE TO PROVIDE FOR THE HEARING OF ARCADIA MUNICIPAL ORDINANCE VIOLATION CASES BY ASSOCIATE CIRCUIT JUDGES AND THE ESTABLISHMENT OF A ARCADIA TRAFFIC VIOLATIONS BUREAU AND RELATED MATTERS.

WHEREAS, the Board of Aldermen of Arcadia, Missouri, have determined on August 8TH \_\_\_\_, 1994, that cases involving violations of the municipal ordinances of the City of Arcadia should be heard and determined by an Associate Circuit Judge.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ARCADIA, MISSOURI, as follows:

SECTION 1. Cases Filed Before Associate Circuit

Judges. All Arcadia Municipal Ordinance Violation Cases
shall be heard and determined by an Associate Circuit

Judge as provided by Section 479.040, RSMo., 1978.

SECTION 2. Traffic Violations Bureau. The City of Arcadia hereby requests the establishment of a Traffic Violations Bureau as provided in Section 479.050, RSMo., 1978.

SECTION 3. Municipal Court Costs. Pursuant to the provisions of Subsection 6 of Section 479.260, RSMo., 1978, the Court costs for each municipal ordinance violation case filed in the Municipal Court shall be in the amount of Fifteen Dollars (\$15.00) per case.

SECTION 4. Traffic Violations Bureau Staff and
Expenses. The position of the Traffic Violations Bureau
Clerk is hereby established. The Clerk shall perform
the responsibilities imposed by or purusant to Section
479.050, RSMo., 1978, with respect to the Traffic
Violations Bureau for the City of Arcadia, including:

(a) Collect fines and costs which are assessed in the Traffic Violations Bureau.

(b) Remit to the proper official fines and costs which are collected within the time and in the manner provided by Statutes, Court Rule or Ordinance.

The salary of the Traffic Violations Bureau Clerk shall be established by the Board of Aldermen.

All other expenses incident to the oepration of the Traffic Violations Bureau shall be paid by the City of Arcadia.

SECTION 5. Repeal of Municipal Court Provision.

All ordinances making provision for the municipal Judge of the City of Arcadia, Missouri, are hereby repealed.

SECTION 6. Sevarability. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereof.

SECTION 7. Effective date. This Ordinance shall take effect immediately upon its final passage by the Board of Aldermen of the City of Arcadia, Missouri.
